At the Extraordinary General Meeting of the Company on 7 June 2018 a total of 6,552,846 shares were represented (out of a total number of 9,090,000 shares in the Company), accounting for 72.09% of the share capital and entitling to a total of 6,552,846 votes at the EGM.

A list of shareholders holding at least 5% of votes at the EGM:

- 1. FIP 11 FIZ Non-Public Assets held 4,202,061 shares and the same number of votes at the EGM, which accounted for 64.13% of votes at the EGM and represent 46.23% of the share capital of the Company:
- 2. Multico sp. z o.o. held 614,890 shares and the same number of votes at the EGM, which accounted for 9.38% of votes at the EGM and represent 6.76% of the share capital of the Company;
- 3. Wartico Invest sp. z o.o. held 509,109 shares and the same number of votes at the EGM, which accounted for 7.77% of votes at the EGM and represent 5.60% of the share capital of the Company;
- 4. Energopol-Warszawa S.A. held 464,519 shares and the same number of votes at the EGM, which accounted for 7.09% of votes at the EGM and represent 5.11% of the share capital of the Company;
- 5. Mr. Zbigniew Jakubas held 442,490 shares and the same number of votes at the EGM, which accounted for 6.75% of votes at the EGM and represent 4.87% of the share capital of the Company;
