Subject: Information received pursuant to art. 69 paragraph 2 Section 2 of the Act on Public Offering - an increase of more than 1% of the total number of votes in the Company

Contents of the Report:

Centrum Nowoczesnych Technologii S.A., with its registered office in Sosnowiec, announces that on 26 November 2015 it was informed by FIP 11 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych, with its registered office in Warsaw, submitted pursuant to art. 69 paragraph 2 Section 2 of the Act On Public Offering of 29 July 2005 and Conditions Governing the Introduction of Financial Instruments to Organised Trading and Public Companies, with the following contents:

"Acting pursuant to art. 69 paragraph 2 Section 2 of the Act on Public Offering and Conditions Governing the Introduction of Financial Instruments to Organised Trading and Public Companies", dated 29 July 2005, Journal of Laws No. 184 item 1539 ("The Act"), CNT S.A. announces that as a result of the acquisition by FIP 11 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych of 97,269 shares of Centrum Nowoczesnych Technologii S.A. (The "Company") on 24 November 2015, the aggregate total number of votes represented by FIP 11 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych and entities acting in agreement, referred to in Art. 87 section 1 item 5 of the Act, ie. FIP 12 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych and Zbigniew Jakubas, together with its subsidiaries within the meaning of the Act, ie. Multico Sp. Z o.o ., Energopol Warszawa S.A., Energopol Trade SA and Wartico Invest Sp. z o.o. increased by more than 1% of the total number of votes in the Company, ie. was increased to 5,854,931 shares, which constitutes to 5,854,931 votes, representing 64.41% stake in the share capital of the Centrum Nowoczesnych Technologii S.A. and the same number of votes.

Prior to the above change, FIP 11 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych and entities acting in agreement, referred to in Art. 87 section 1 item 5 of the Act, ie. FIP 12 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych and Zbigniew Jakubas, together with its subsidiaries within the meaning of the Act, ie. Multico Sp. z o.o., Energopol Warszawa S.A., Energopol Trade S.A. and Wartico Invest Sp. zo.o. held a total of 5,757,662 shares, representing 63.34% of the share capital of the Company. Owned total shares entitled to 5,757,662 votes at the General Meeting and represented 63.34% of the total number of votes.

FIP 11 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych and FIP 12 Fundusz Inwestycyjny Zamknięty Aktywów Niepublicznych declare that there are no entities depended on them under the Act. Subsidiaries of Zbigniew Jakubas, and also shareholders of the Company, are Multico Sp. zoo. with its registered office in Warsaw, Energopol - Warszawa SA with its registered office in Warsaw, Energopol - Trade SA with its registered office in Warsaw and Wartico Invest Sp. zo.o. with its registered office in Warsaw. "
