At the same time, acting pursuant to § 101 sec. 2 of the Ordinance of the Minister of Finance dated 19 February 2009 on current and periodic information submitted by issuers of securities and conditions for recognizing as equivalent information required by laws of non-member state - consolidated text: Journal of 2014, pos. 133 (the "Regulation"), the Issuer informs that it will not publish consolidated quarterly report for the second quarter of 2016.

The Management Board of Centrum Nowoczesnych Technologii S.A. further states that:

- according to § 83 sec. 1 of the Regulation, the Company will publish the consolidated quarterly reports for the fourth quarter of a financial year 2015 and for the first and third quarter of a financial year 2016 containing quarterly financial information of the parent company and will not submit individual separate quarterly reports for the reporting periods;
- according to § 83 paragraph. 3 of the Regulation, the Issuer will not publish standalone semi-annual report, and thus the consolidated report for the first half of 2016 will include the condensed interim financial





statements together with the report of the entity authorized to audit financial statements and additional information.

§ 103. 1. An issuer is required to identify and publish by the end of the first month of a given financial year, in a current report, fixed dates of publishing periodic reports in the financial year, including days recognized under separate provisions for non-working days
